Applying for 501(c)(3) can be done online or by downloading and mailing Form 1023, Application for Recognition of Exemption under Section 501(c)(3). A ministry must submit its application within 27 months from the end of the month in ...

1023 Application for Recognition of Exemption

When the Internal Revenue Service looks at a 501c3 application for churches, it applies a set of criteria called the 14/15 Point Test. This test helps the IRS and courts determine whether an entity should be categorized as a church for tax reasons. Some points have greater gravity than others. The following are some of the points:

Governance. Sample Church shall be a church that is pastor-led and subject to the apostolic authority of the Council of Overseers as described herein. The Pastoral Leadership Team of Sample Church shall act as the governing authority by providing spiritual guidance, setting its major policies, and exercising responsibility for its business
